In This Report

In July 2019, Recovery Specialists were deployed to patients' bedsides 1,663 times, representing a 24% increase compared to June 2019. **This increase is due primarily to the implementation of automatic referrals for recovery support services** at eight RWJBarnabas Health hospitals. Referrals can be placed through a non-physician order or automatically based on certain criteria (e.g., positive screening questions, administration or prescription of naloxone or buprenorphine, and use of clinical withdrawal tools). Automatic referrals will be implemented at additional sites.

The July 2019 Monthly Report presents information on deployments, the population served, and program outcomes. The information included in this report is preliminary and subject to change.


Program Background

The RWJBarnabas Health (RWJBH) Institute for Prevention and Recovery (IFPR) Peer Recovery Program (PRP) provides recovery support services for individuals with substance use disorder identified by the hospital. The PRP employs Recovery Specialists who are in long-term recovery from substance use disorder and provide bedside intervention and peer recovery support as well as clinically-trained Patient Navigators who link individuals to appropriate levels of care.

The PRP, formerly known as the Opioid Overdose Recovery Program (OORP), serves patients 24 hours a day, 7 days a week in 19 hospitals throughout Essex, Hudson, Middlesex, Monmouth, Ocean, Somerset, and Union counties. A list of participating hospitals is included in the Appendix. This list includes an Expansion Date for each hospital that denotes when the PRP expanded beyond serving only emergency department patients who received naloxone; the PRP now serves patients with substance use disorder in emergency departments of all participating hospitals and patients with substance use disorder in inpatient units of RWJBH hospitals.

Deployment Summary


Recovery Specialists were deployed to patients' bedside **1,663 times** in July 2019. There were on average 1,220 deployments per month in the preceding 11 months. There were 9,060 deployments in 2018, 1,898 deployments in 2017, and 720 deployments in 2016.








Population Served

Of the 1,663 patients subject to deployment, fewer than one in eight patients received at least one dose of naloxone prior to bedside intervention. Approximately two-thirds of the patient population was male. Most patients were between the ages of 26-44 (40.6%) and 45-64 (44.7%). The majority (54.2%) of patients were white, 24.2% were black, and 15.3% were Hispanic/Latino. Over half of all patients were covered by Medicaid or were uninsured, 14.2% were homeless, and 40.9% did not have access to transportation. Throughout this report, "Unknown" consists of responses of "do not know" or "refused" and missing data. Additional data is available in the Appendix.



















Program Outcomes

To measure success, the Institute for Prevention and Recovery utilizes the Substance Abuse and Mental Health Services Administration's (SAMHSA's) working definition of recovery, which emphasizes the process of change through which individuals improve their health and wellness, live self-directed lives, and strive to reach their full potential. Four major dimensions—health, home, purpose, and community—support recovery. The PRP assists in the process of recovery by providing recovery support services and clinical referrals.

In July 2019, 35 patients were not available for services (i.e., patient left against medical advice, incoherent, incarcerated, deceased, etc.). **90.8%** of patients available for services accepted bedside deployment by a Recovery Specialist. **89.3%** of patients who accepted bedside deployment also accepted some form of recovery support services.













Program Outcomes (continued)

In July 2019, patients accepted 183 referrals to withdrawal management and 271 referrals to treatment either at bedside or during follow-up. The types of accepted referrals are shown below and in the Appendix.





Recovery Specialists conduct follow-up with patients for eight weeks post-deployment. In July 2019, **PRP staff conducted 9,627 instances of follow-up, including 1,551 face-to-face contacts**. Patient Navigators were responsible for one-quarter of all instances of follow-up.




